

# FY 2015 Appropriations Update: Senate Appropriations Subcommittee Approves Labor, Health and Human Services, Education, and Related Agencies Bill; Full Committee Consideration Delayed

On June 10, the Senate Labor, Health and Human Services, Education, and Related Agencies Appropriations Subcommittee cleared its fiscal year (FY) 2015 appropriations bill, which funds the Department of Health and Human Services (HHS), the Department of Education (ED), and the National Institutes of Health (NIH), among other agencies. Many of the bill's details are not yet available, but press releases from Appropriations Committee Chair Barbara Mikulski (D-MD) and Subcommittee Chair Tom Harkin (D-IA) emphasize the difficult decisions made due to last year's bipartisan budget agreement, which set overall funding for the bill at the same level as FY 2014.

Consideration of the bill by the full Senate Appropriations Committee has been postponed indefinitely, reportedly due to threat of amendments related to implementation of the *Patient Protection and Affordable Care Act* (ACA), which would force some Members to take tough political votes during an election year. The bill is unlikely to be considered on the Senate floor at least until the lame-duck session following the elections. This, coupled with similar reluctance in the House to force a difficult vote, and the recent shake up in Republican leadership due to the primary loss of Majority Leader Eric Cantor (R-VA) means the FY 2015 budgets for these programs will likely be determined by a House-Senate conference committee late this year or early next year.

Below is an overview of the bill, with specific funding details available in the charts.

## **Department of Health and Human Services (HHS)**

#### National Institutes of Health (NIH)

The bill would provide \$30.5 billion for NIH in FY 2015, an increase of \$605.7 million (2 percent) above last year. The Appropriations Committee press release notes that this increase combined with the \$1 million increase in FY 2014 fully replaces the FY 2013 sequester cut to the agency. The Committee also points out that the proposed FY 2015 increase would allow NIH to allocate \$100 million to the BRAIN Initiative, which is the same level recommended in the President's budget request.

Most institutes and centers (IC) would receive approximately a 1.5 percent increase above FY 2014. Of note, the Subcommittee addressed Republican concerns over the effect of the HHS evaluation tap on the NIH budget by transferring \$808.2 million to the agency under the tap and having NIH contribute \$693.3 million to tap activities, resulting in a net increase of \$111.9 million. The Senate bill would ensure this increase of transfer funding for NIH does not decrease funding for agencies that typically rely on tap funding, such as the Agency for Healthcare Quality and Research (AHRQ). If and when a House version of this bill is released, there are likely to be similar changes to the evaluation tap, but programs like AHRQ that evaluate the effectiveness of ACA and other activities will not be protected.

While no reason is given, the \$808.2 million in NIH tap money is allocated to the National Institute of General Medical Sciences (NIGMS), which has its base budget cut by \$763 million, resulting in a \$45 million increase (1.9 percent) for that Institute. Within NIGMS, the Institutional Development Award (IDeA) program, which seeks to broaden the geographic distribution of NIH funding and is popular with many appropriators, would receive \$275.4 million, an increase of \$2.1 million above last year.


### Other Department of Health and Human Services Programs

Overall, health professions programs under Title VII and VIII at the Health Resources and Services Administration (HRSA) would receive \$470.5 million, which is \$1.3 million (0.3 percent) increase above the FY 2014 level. Title VII programs would receive \$234.2 million in the Subcommittee bill, which is an \$11.1 million decrease (4.6 percent) below the FY 2014 level. Within Title VII programs, the Subcommittee's bill would eliminate funding for the Centers of Excellence program, Health Careers Opportunity Program, and Faculty Loan Repayment Program. Mental and behavioral health programs would receive \$9.9 million, which is a \$2.0 million increase above the FY 2014 level, and the Scholarships for Disadvantaged Students program would receive \$57.9 million, which is an almost \$13 million increase (29 percent) above the FY 2014 level. Title VIII nursing workforce development programs at HRSA would receive \$236.3 million in the Subcommittee's bill, which is a \$12.5 million (6 percent) increase over the FY 2014 levels. The Children's Hospital Graduate Medical Education Payment Program (CHGME), eliminated in the President's budget proposal, would receive \$265 million in the Subcommittee bill, which is the same as the FY 2014 level.

Regarding other top-line funding at HHS, the Centers for Disease Control and Prevention would receive \$7.1 billion in the Subcommittee bill, a \$171.0 million (3 percent) increase above the FY 2014 level. The Substance Abuse and Mental Health Services Administration would receive \$3.6 billion, which is \$42.7 million (1 percent) below the FY 2014 level. As mentioned above, AHRQ would be funded through direct appropriations rather than the evaluation tap. The Subcommittee's bill would provide \$373.3 million in direct appropriations for AHRQ, which is a \$2.3 million (0.6 percent) increase above the FY 2014 level. In addition, the Administration on Community Living would receive \$1.7 billion, which is an increase of \$20.7 million (1 percent) above the FY 2014 level. According to information released by the Subcommittee, part of this funding includes \$10 million for a new Elder Justice initiative focused on developing partnerships across disciplines for the prevention, investigation, and prosecution of abuse. This includes financial abuse against the elderly.

### Department of Education (ED)

The Subcommittee bill would continue funding for several of President Obama's education priorities, including Race to the Top, Investing in Innovation, and the new First in the World program. The Subcommittee rejects the \$52 million requested by the President to develop and implement the proposed higher education rating system, but would fund the higher education program evaluation account at \$1 million, an increase of \$510,000 over FY 2014. The bill also includes \$81.2 million for Title VI international programs, a \$9 million increase over FY 2014, and \$31 million for the Graduate Assistance in Areas of National Need (GAANN) program, a \$1.7 million increase over FY 2014. The Javits program was folded into GAANN several years ago; advocates are hopeful that part of the increase would support fellowships in the humanities. TRIO would be funded at \$846.6 million, an increase of \$8.4 million over FY 2014 and level with the President's request. GEAR UP would receive \$304.6 million, an increase of \$3 million over current law and also level with the President's request. The Institute of Education Sciences (IES) would receive \$579 million, a \$2 million cut from FY 2014 funding and well below the President's request of \$637.2 million.



#### **Student Financial Aid**

Overall, the Subcommittee would provide level funding for the major federal student aid programs, with a few small increases. The Subcommittee would level fund the maximum Pell Grant at \$4,860 with discretionary dollars and increase the maximum grant to an estimated \$5,830 for 2015-2016 when mandatory funding is included. The Senate would provide \$1.01 billion for Federal Work Study, an increase of \$35 million over FY 2014; and \$748 million for the Supplemental Education Opportunity Grants (SEOG), an increase of \$15 million over FY 2014.
